Pursuant to University Regulations for the awarding of scholarships pursuant to art. 18, paragraph 5, of law 240/2010 issued with D.R. n.468 of 03/03/2023;

Pursuant to article 18, paragraph 5, letter f of the Law no. 240/2010 as amended by art. 49 of the Legislative Decree no. 5 of 09/02/2012, converted with Law n. 35 dated 04/04/2012, pursuant to which participation in research groups is also permitted for holders of scholarships and research grants announced on the basis of specific agreements and without financial charges for the University;

Pursuant to the request presented by Dr. Pietro Goglio, concerning the establishment of a research scholarship, fully funded to carry out post-graduate research activities at the Department of Agricultural, Food and Environmental Sciences within the research project: "BIOSCHAMP, BIOStimulant alternative casing for sustainable and profitable mushroom industry";

Pursuant to the authorization to issue the recruitment call with resolution of the Council resolution of the Department of Agricultural, Food and Environmental Sciences n.5/8A/2023 of 11/05/2023;

Considering that the no candidate applied for the research scholarship call related to the announcement prot. n.158207/2023, D.D. N.072/2023;

Considering that the financial coverage of the scholarship will be provided by the GOGH2020BIOSCHAMP research fund, where Dr. Goglio is University leader.

ISSUES

The following decree for the notice of competition

Art. 1 - Object

The comparative selection procedure, based on Curriculum Vitae (CV) assessment and interview, has been announced for the award of the following for the research scholarship, with a 14 months duration, possibly extendable, starting from 01/08/2023 to 30/09/ 2024, for a total amount of 25,000.00 (twenty-five thousand/00) euros, for carrying out research activities at the Department of Agricultural, Food and Environmental Sciences;

3. Having less 30 years of age on the expiry date of the call.

Art. 3 – Application for participation

Applications for participation in the competition, to be drawn up on unstamped paper, according to attachment Mod. A, accompanied by the required documentation, must be addressed to the **Head of the Department of Agricultural, Food and**

Environmental Sciences of the University of Perugia and may be presented or sent in a single envelope to the **Administrative Secretary - of the Department of Agricultural, Food and Environmental Sciences of the University of Perugia, Via Borgo XX Giugno n.74, 06121 PERUGIA**, no later than 20 days from the date of publication of the announcement and in any case **no later than 1.00 pm on 24/07/2023**, under penalty of exclusion from the competition.

Applications sent in a single pdf file will be accepted, by certified e-mail to the following address: dipartimento.dsa3@cert.unipg.it.

Applications received after this deadline, even if sent by post, will not be taken into consideration. Therefore, only the arrival stamp of the protocol of the Department of Agricultural, Food and Environmental Sciences will be considered valid.

Failure to affix the handwritten signature to sign the application leads to the exclusion from the competition.

Applications submitted by fax or photocopy will not be accepted.

The Administration assumes no responsibility for any communication errors due to inaccurate indications of residence and address by the applicant or failure or late communication of the change of the same, nor for any postal or telegraphic errors not attributable to the fault of the administration itself.

Art. 4 – Preparation of the application

The candidate must declare under her/his own responsibility:

1. personal details, date and place of birth, citizenship, residence and address chosen for the purposes of the competition (specifying the postal code and, if possible, the telephone number);
2. the area and the project for which she/he intends to compete;
3. the degree held with the indication of the date and of the University where it was obtained, as well as the mark obtained;
4. not to receive any research funding, award for any reason, during the period of validity of the one for which the applicant is applying;
5. to promptly communicate any change of residence or of the address indicated in the application for admission.
6. to continuously carry out research activities within the reference structure of the chosen project.
7. not to have any fourth or lower degree family relations, even if deriving from civil unions pursuant to Law 20 May 2016, n.76), with a professor, researcher belonging to the structure requesting the scholarship or with the Rector, the General Manager or a member of the University Board of Directors;
8. not to be in situations, even potential ones, of conflict of interest (under penalty of exclusion from the selection itself), in compliance with art. 53, paragraph 14, Legislative Decree 165/2001, as amended by art. 1, paragraph 42, Law 190/2012;
9. to abide by the Code of Conduct of this University.

Applicants must attach to their application:

- a) MD certificated on unstamped paper, or self-declaration, in accordance with C form certifying possession of the Degree Diploma with the final grade and the grades obtained in the individual exams;
- b) Curriculum vitae, dated, signed and accompanied, under penalty of non-evaluation, with a declaration, pursuant to art. 47 of the Presidential Decree 445/2000, made using

form B, with which the candidate certifies, under his own responsibility, that what is stated therein is true;

c) publications and any other titles in a single copy; only the titles produced in the original or in a conformed copy together with a self-declaration pursuant to art. 47 Presidential Decree 28.12.2000, no. 445 in accordance with the attached Form B. Furthermore, the qualifications declared will be evaluated, pursuant to art. 46 Presidential Decree 28.12.2000, no. 445, in the application to participate in the competition or by substitutive declaration of certification, in accordance with the attached C form. The qualifications written in a foreign language must be accompanied by a translation into Italian, certified as conforming to the foreign text, drawn up by the competent diplomatic mission or consulate or by an official translator or certified as conforming to the foreign text by means of a self-declaration pursuant to art. 47 Presidential Decree 28.12.2000, no. 445, in accordance with the attached B form.

e) photocopy of a valid identity document.

The applicant's name, surname and address must appear on the envelope; the name and surname of the candidate must also be written on each of the works presented. References to documents and publications already presented in other competitions are not permitted.

The qualifications must be produced together with the application or they must be presented to this Administration or sent by registered mail within the deadline for submitting the applications, under penalty of non-evaluation. Other qualifications submitted subsequently cannot be taken into consideration.

Art. 5 – Commission of examination and interview

The recruitment selection is based on qualifications and interview.

The recruitment committee, is appointed by Decree of the Director of the Department on the basis of a proposal from the project manager, and is made up of the Project Manager and two other professors belonging to the scientific research area.

100 marks can be attributed by the committee, **20** on the basis of qualifications and **80** on the basis of the interview.

The qualifications assessment, which is based on a criteria formulation, will be carried out by the Committee before the interview.

The interview will be carried out in "virtual room" mode and will take place on **27/07/2023 starting at 10:00**.

The candidate must contact the Project Manager to agree on the time of the interview on the day indicated above, the contact to be used is: **Microsoft Teams platform: Pietro Goglio, pietro.goglio@unipg.it**

This notice is the only communications the candidate will receive, no further official communications will be given to the candidate prior the interview.

Candidates who cannot be found in "Virtual room" mode on the aforementioned day and time will be excluded from the selection.

To participate to the interview, candidates must show one of the following valid identification documents:

- identity card;
- driving license;
- passport;
- Any piece of id, as long as they bear a photograph and a stamp or other equivalent signature, issued by a State administration;
- other equivalent documents pursuant to art. 35 paragraph 2 of the Presidential Decree No. 445 of 12/28/2000.

Upon candidate request, the interview can also be carried out in English and will focus on the following topics:

- analysis of the life cycle of agricultural systems; statistical methods in agriculture; carbon and nitrogen balances in agricultural systems; knowledge of the English language; knowledge of SimaPro software.
- Agricultural LCA, Statistical methods in agriculture, C and N budget in agricultural systems, knowledge of the English language and SimaPro software.

Once the interviews have been concluded, the recruitment committee will formulate an overall judgment for each candidate and will compile the ranking of suitable candidates, meaning those who have achieved a score of no less than **48/80** in the interview. Scholarships will be awarded on the basis of this ranking. In case of equal mark, the candidate with lower age will be selected.

To the selected candidates, a written communication will be given on the scholarship attribution. Under penalty of forfeiture, they must submit, within the peremptory term of 15 days from the date of receipt of the aforementioned communication:

1. declaration of acceptance of the scholarship, according to the form prepared by the Office.
2. Scholarship holders are required to take out a specific accident insurance policy, presenting a copy to the Head of the Department. For information please contact: dipartimento.dsa3@cert.unipg.it
3. Failure to accept within the term indicated above will result in the scholarship exclusion.

Art. 6 - Obligations

The scholarship holder is obliged to start the activity on the scheduled date and to carry out the activity regularly and uninterruptedly for the entire duration of the research scholarship, according to the directives given by the Scientific director.

Any postponement of the start date or interruptions in the period of enjoyment of the scholarship will be allowed to the winners who demonstrate that they have to satisfy military obligations or who are in the conditions provided for by law 12/30/1971 n.1204 on condition that the start of the research activity is in any case fixed within the following academic year as per art.1.

Those who find themselves in the aforementioned situations are required to exhibit:

- if they have to demonstrate that they have to fulfill military obligations, a certificate from the military authorities which must also indicate the date on which the military service will end;

- where they have to demonstrate that they are in the conditions set forth by law 30/12/1971 n. 1204, a medical certificate which must indicate the periods of compulsory abstention pursuant to the aforementioned law.

The documentation referred to in the previous two points may also be presented by means of a self-declaration pursuant to art. 47 Presidential Decree 28/12/2000, no. 445 in accordance with the attached B form.

The committee of Department of Agricultural, Food and Environmental Sciences may order, upon proposal of the Head of the research project, the cancelation of the awarded research scholarship, if the research scholarship holder do not fulfill the commitments set out in this decree.

Interested candidates can request, at their expense, within six months of the completion of the competition, to receive all the documents and any publications sent to the University of Perugia. After this period, the Administration will proceed with the elimination of the aforementioned documents from its archives.

Art. 7 – Non cumulation rule

The scholarship referred to in this announcement cannot be combined with any other scholarship or research scholarship awarded for any reason, except with that granted by national or foreign institutions useful for integrating, with stays abroad, the training or search for the research scholar. The scholarship cannot be combined with other research grants. The scholarship holder is required to declare, under his own responsibility, the non-existence of hypotheses of scholarship or research grant cumulation and to promptly communicate any occurrence.

Entitlement to the scholarship is incompatible with any permanent or fixed-term employment relationship, without prejudice to the possibility that the scholarship holder may be placed on unpaid leave by the employer.

The research scholar is engaged full-time and exclusively in the activities related to the research project for which he has been recruited.

Scholarship holders are required to comply with the University's Code of Ethics and Conduct, as well as other internal regulations.

The research scholar is also required to maintain the confidentiality of any information directly or indirectly learned in relation to the activity covered by the fellowship.

Art. 8 – Payment method

The scholarship payment is made through deferred monthly instalments, except for possible suspension of the grant proposed by the Head of the research project due to serious non-compliance by the scholarship holder in carrying out his/her activity or due to absences of more than thirty days.

Scholarships do not give rise to social security benefits or assessments for legal and economic careers or automatic recognition for social security purposes.

Art. 9 - Data treatment

Pursuant to art. 10, first paragraph, of law 12/31/1996, n. 675, the personal data provided by the candidates will be collected at the University of Perugia for the purposes of managing the competition and will be processed in an automated database even after the establishment of the employment relationship.

The provision of such data is mandatory for the purposes of evaluating the participation requirements, under penalty of exclusion from the competition.

Article 10 - Publication
